LEGAL DESCRIPTION

HAVING A RADIUS OF 325.00 FEET. A CENTRAL ANGLE OF 12°47'19" AND A CHORD WHICH BEARS N04°56'38"W A DISTANCE OF 72.39 FEET: THENCE CONTINUING ALONG SAID PROPOSED RIGHT-OF-WAY, N11°20'18"W A DISTANCE OF 122.32 FEET TO A POINT OF CURVATURE; THENCE 120.62 FEET ALONG THE ARC OF SAID CURVE TO THE RIGHT. HAVING A RADIUS OF 215.00 FEET, A CENTRAL ANGLE OF 32°08'39" AND A CHORD WHICH BEARS N04°44'02"E A DISTANCE OF 119.04 FEET TO A POINT OF CURVATURE ON THE SOUTHWESTERLY RIGHT-OF-WAY LINE OF 16TH STREET; THENCE DEPARTING SAID RIGHT-OF-WAY LINE OF PROPOSED WEWATTA STREET ACROSS 16TH STREET AND A PORTION OF LOT 16, BLOCK 9, EAST DENVER 89.37 FEET ALONG THE ARC OF SAID CURVE TO THE RIGHT, HAVING A RADIUS OF 215.00 FEET, A CENTRAL ANGLE OF 23°49'03" AND A CHORD WHICH BEARS N32°40'11"E A DISTANCE OF 88.73 FEET TO A POINT ON THE SOUTHEASTERLY RIGHT-OF-WAY LINE OF PROPOSED WEWATTA STREET: THENCE ALONG SAID PROPOSED SOUTHEASTERLY RIGHT-OF-WAY N44°34'00"E A DISTANCE OF

HOYT AND ROBINSON'S ADDITION TO DENVER, SAID POINT BEING 62.48 FEET SOUTHEAST OF THE NORTHWEST CORNER OF SAID BLOCK D; THENCE S44°34'06"W ALONG A LINE MIDWAY BETWEEN THE NORTHWEST LINE OF BLOCK D AND THE NORTHWEST LINE OF THE ALLEY IN BLOCK D, A DISTANCE OF 441.44 FEET; THENCE S45°29'18"E, A DISTANCE OF 203.53 FEET; THENCE S44°34'08"W ACROSS VACATED 18TH STREET, A DISTANCE OF 40.00 FEET TO THE POINT OF BEGINNING.


